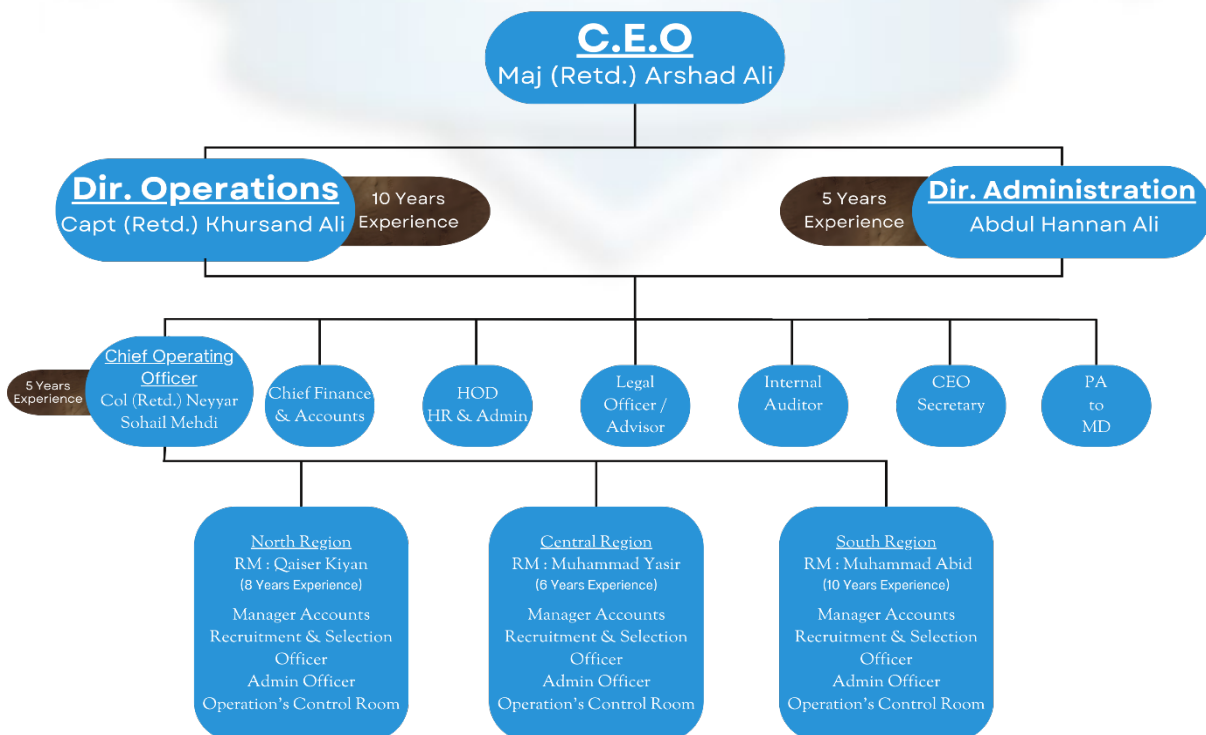

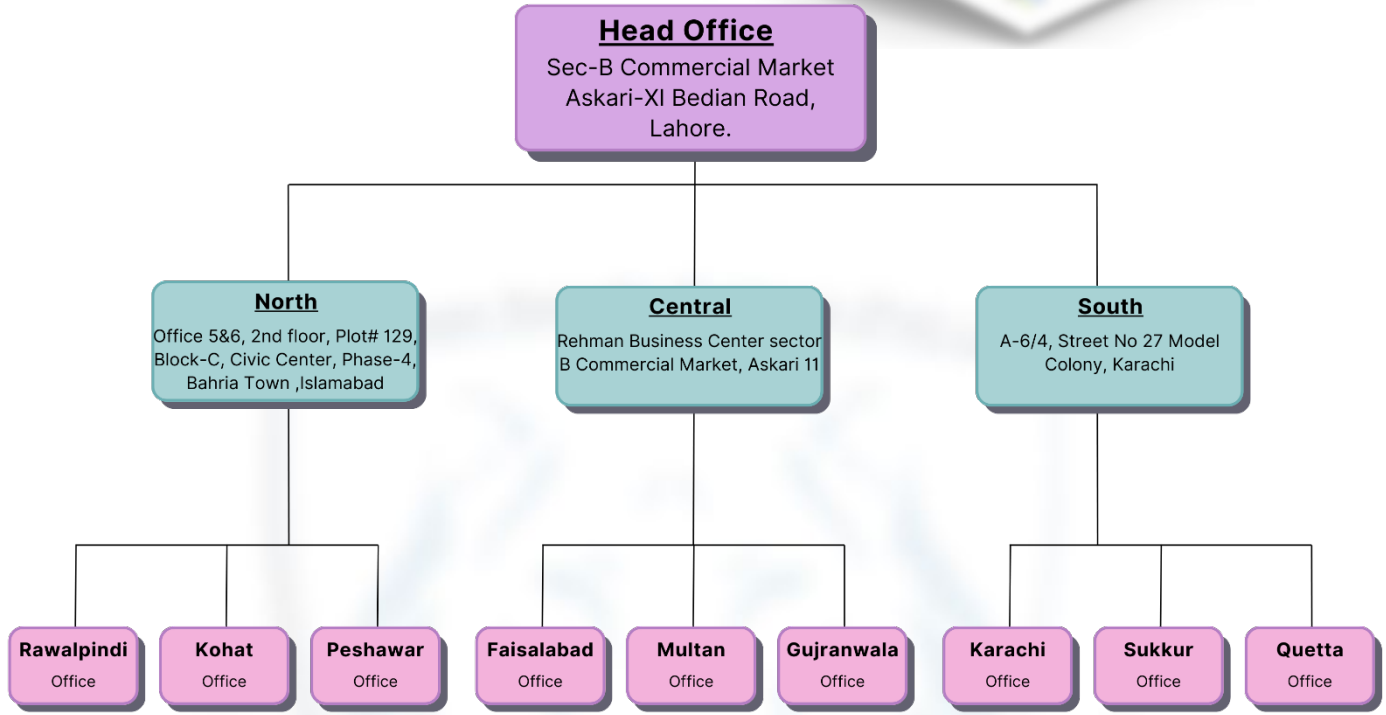
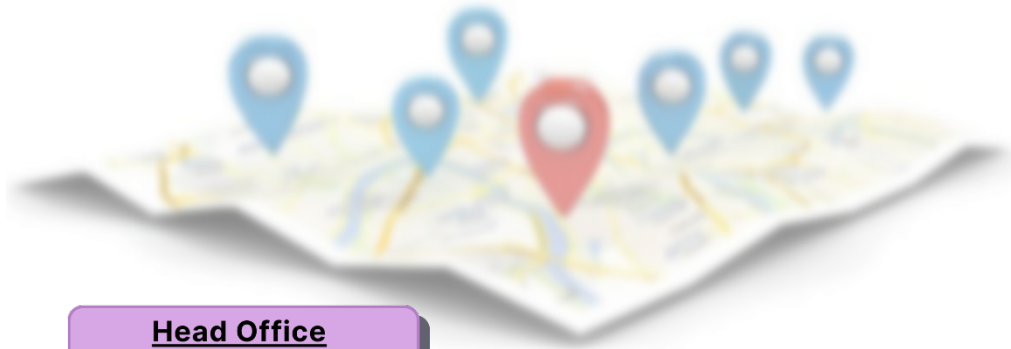

Government of the Punjab, Home Department may please refer to their U.O.No.8-9-II.Spl.II/2002 dated 12.8.2002. In this regard it is intimated that M/s. Rehman Security Systems (Pvt) Limited was incorporated in October 1998 by Registrar of Companies, Azad Jammu & Kashmir under the Companies Ordinance, 1984 (as adopted in AJ&K). The said foreign company filed certain documents under section 451 of the Companies Ordinance, 1984 for establishment of a place of business in Pakistan. The documents after thorough examination were forwarded to Ministry of Interior, which granted a No Objection Certificate, vide letter No.4/56/2000-Security.III dated 29.9.2001 for carrying out security business as enunciated in the Memorandum of Association of said entity. The foreign company which establishes a place of business in Pakistan is only required to deliver certain documents to the respective Company Registration Office under above said provisions and the concerned registrar issues an acknowledgement of filing and said acknowledgement is a proof that company complied with certain legal requirements for establishment of place of business in Pakistan. The foreign companies are not required to obtain certificate of incorporation. The procedure adopted by the above foreign company was in line with the requirements of law.

No.2(536)-Home/2007: - In exercise of the powers conferred upon him under Section 6(2) of the Private Security Companies Ordinance, 2001 and Rule 3(1) made there-under, the Chief Commissioner, Islamabad Capital Territory has been pleased to grant license to M/S **Rehman Security Systems (Pvt.) Ltd**, Office No.11, Zahid Plaza, Sector I-10 Markaz, Islamabad, to operate as a Private Security Company in Islamabad Capital Territory subject to the following terms and conditions: -

- (i) The company will abide by all legal and codal restrictions/instructions issued from time to time for operation of security companies including those in the Private Security Companies Ordinance, 2001 and Ministry of Interior's instructions contained in their NOC.
- (ii) The company will abide by all the instructions issued by Ministry of Interior or ICT Administration from time to time in future.
- (iii) The company will send monthly report regarding operation of the company and compliance of the laws/instructions.
- (iv) The company will not indulge in any illegal business and will not provide security to any illegal activity / business.
- (v) The company will furnish a list of employees on the 1st of each month to the Sr. Superintendent of Police, Islamabad, AIG/Special Branch, Islamabad for updating the record. No person shall be recruited unless he has been cleared by SSP, AIG/Special Branch, Islamabad. Company will also furnish a security clearance certificate of all its security guards cleared by Special Branch, Islamabad on monthly basis i.e. in the 1st week of each month.
- (vi) The company will provide complete details of vehicles in use to SSP, Islamabad and also of all subsequent changes/replacements in this regard one week in advance.
- (vii) The company shall use the following pattern of uniform (which its employees will wear) as approved by the Ministry of Interior: -
 - a. Trousers of Navy Blue colour without any piping.
 - b. Shirt Navy Blue colour with security badge on shoulders and a badge with the insignia of the company of black colour having the name of the company embroidered on it in white colour on the left shoulder.
 - c. Beret cap of black colour with a small size badge with the insignia of the company embroidered in white colour.
 - d. Belt black (leather on nylon) with rectangular steel buckle with the insignia of company.
- (viii) The security guards will display the badge or emblem as approved above. They will also display I.D. Cards containing their company's name, the individual guard's photograph issued by the company and the company shall have to deposit the specimen of I.D. Card with the Special Branch Police, Islamabad.

- (ix) The security guards must have requisite training for guard duties and use of arms from the following training institutions approved by the Ministry of Interior. No other institution is allowed to impart training to the guards of Private Security Companies except after inspection of the training facilities by a Committee constituted by the Interior Division.
- i. Fauji Foundation.
 - ii. Askari Guards (Pvt.) Ltd.
 - iii. Provincial Police Training Institutes.
- (x) The Private Security Company shall be governed by all relevant laws/rules applicable.
- (xi) The company shall furnish a complete kit of the above mentioned uniform to the Office of Inspector General of Police, ICT as a specimen/standard uniform of the company.
- (xii) The company will not permit any person other than the security personnel to travel in its vehicles.
- (xiii) The company shall in no way exercise or appear to exercise authority in excess of that allowed by law to ordinary citizens.
- (xiv) The office of the company will be opened to periodic inspection by the Senior Superintendent of Police or any Police Officer authorized by him.
- (xv) The company shall provide a wireless set to the Islamabad Police for communicating with them at all times.
- (xvi) The Private Security Companies may provide "No Demand Certificate" from the Income Tax Department to the Office of the Chief Commissioner, ICT, on annual basis.
- (xvii) Private Security Company will abide by its undertaking that the management shall not transfer/hand over/sub-let the company to any other person/party in any form.
- (xviii) The company is not allowed to render its services to the owners of Key Points under the Government.
- (xix) The company shall apply for renewal of its license one month prior to the expiry of the license supported by Bank Challan of renewal fee of Rs.5,000/- or the fee revised from time to time.
- (xx) The license of M/S **Rehman Security Systems (Pvt.) Ltd**, may be cancelled if its performance is not found satisfactory.
- (xxi) The license will be liable to cancellation in case of violation of any of the above conditions by the said company or if activities of any of its employees are found prejudicial to the State or for any other reason considered to be necessary.

3. Conditions for issuance of a licence to a Private Security Company.

The Private Security Company while applying for a licence shall fulfill the following conditions.

- a) The application for Licence shall be made to competent authority indicating the area of activity with in the Province.
- b) The Private Security Company must be registered under the Companies Ordinance, 1984(XLVII of 1984);
- c) The application for the issuance of Licence shall be accompanied with following essentials;
- d) Names and addresses of the licences and Directors;
- e) Work and task already being performed at various places in Pakistan and since how long; and
- f) Bank statement showing the financial position of the Private Security Company.

4. Mode Of Operation.

- (1) On grant of Licence, Private Security Company shall operate in the Province in the mode prescribed as under: -
 - a) It shall keep the Department, the DCO and Superintendent of Police informed about any agreement concluded with a client;
 - b) It shall inform the local police station or Levies Thana about the place of their operation and full particulars of the staff employed, the weapons issued/used and the nature and extent of their obligation

under intimation to the DCO and the Superintendent of Police concerned.

- c) Any change of variation in this regard shall also be reported promptly to the local police/levies station.
 - d) The Police/levies concerned shall have the right to carry necessary check as they are authorized in the case of chowkidari system, at any time;
 - e) Quarterly reports indicating the general activities of the Private Security Company shall invariably be sent to the Department;
 - f) It shall follow the laws, rules policy and instructions on the subject as and when framed by the government and shall conduct its operations in accordance with such directions as Government may issue, from time to time, to regulate and control their working; and
 - g) Change in address office location shall be promptly conveyed to the Department.
- (2) The Private Security Companies to whom licence has already been issued, should regularize themselves under this Ordinance within a period of two months.

5. Uniform.

The Private Security Company shall make an application to Department for getting the pattern of uniform of their employees.

6. Security Guards.

- (1) The Private Security Company shall provide a list of the security guards, working in the filed to be employed and deployed by it in the Province alongwith their credentials and complete information.
- (2) The numbers of security guards shall not be less than 20 and not more than 400 at a time.
- (3) A security guard shall not be less than 25 years and not more than 45 years.
- (4) In order to employ a retired Government official as a security guard, the manager of the Private Security Company shall provide a moral/character certificate from the concerned department alongwith following essentials;
 - a) Medical fitness certificate.
 - b) Copy of I/D Card in triplicate; and
 - c) Photograph and finger prints;
- (5) The Private Security Company shall provide for the training of their security guards and a refreshing course at least once in 3 years.
- (6) The Private Security Company may engage civilian personnel in case sufficient training provided to them.
- (7) All field staff of a Private Security Company to be employed/deployed in province will have to be cleared by the Special Branch of the Department. In case of employee from the tribal area, the verification will be carried out by the concerned Political Agent.
- (8) If any security guard of the Private Security Company is involved in theft, dacoit, robber/murder, treason or anti-state activities etc, the Private Security Company shall be held jointly and variously responsible and shall be liable to any legal action to be taken for it

by the competent authority and the competent authority shall have a vested right to cancel its licence.

7. Fee Structure.

1. The company shall deposit refundable security amount of Rs.2,00,000/- with Government or Bank guarantee of equal amount.
2. The Private Security Company shall pay an amount of Rs.50,000/- to the Government as Licence fee.
3. The Private Security Company shall also pay amount of RS.25,000/- as a yearly renewal fee to the Government.

8. Weapons.





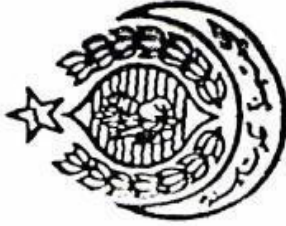

It is liable to pay monthly social security contribution right from the date of above referred notification or the date of commencement of its business/work whichever is later, in respect of its all eligible employees/workers at prescribed rate of 6% of applicable minimum/maximum wage/salary from time to time as per provisions of the above Ordinance and the relevant Rules/Regulations.
- iii. It will be responsible to ensure timely payment of monthly social security contribution and fulfill necessary formalities in this regard.
- iv. The establishment shall maintain record of its employees and shall submit such returns to IESSI as per prescribed format as and when required.
- v. The authorized officials of IESSI shall check the books and record of the establishment to ascertain the correctness of any information as per provisions of the above Ordinance, if and when required.
- vi. The social security benefits shall be extended to eligible employees as per provisions of the Ordinance after completion of required formalities.
- vii. The establishment shall be responsible to meet any liability on account of concealment of facts.
- viii. Acceptance of any subsequent change in the existing reported strength of eligible employees would be subject to verification.
- ix. Any change in address would required to be intimated to this office forthwith.
- x. In case of separation of any employee, his social security card and medical book would be required to be returned immediately.
